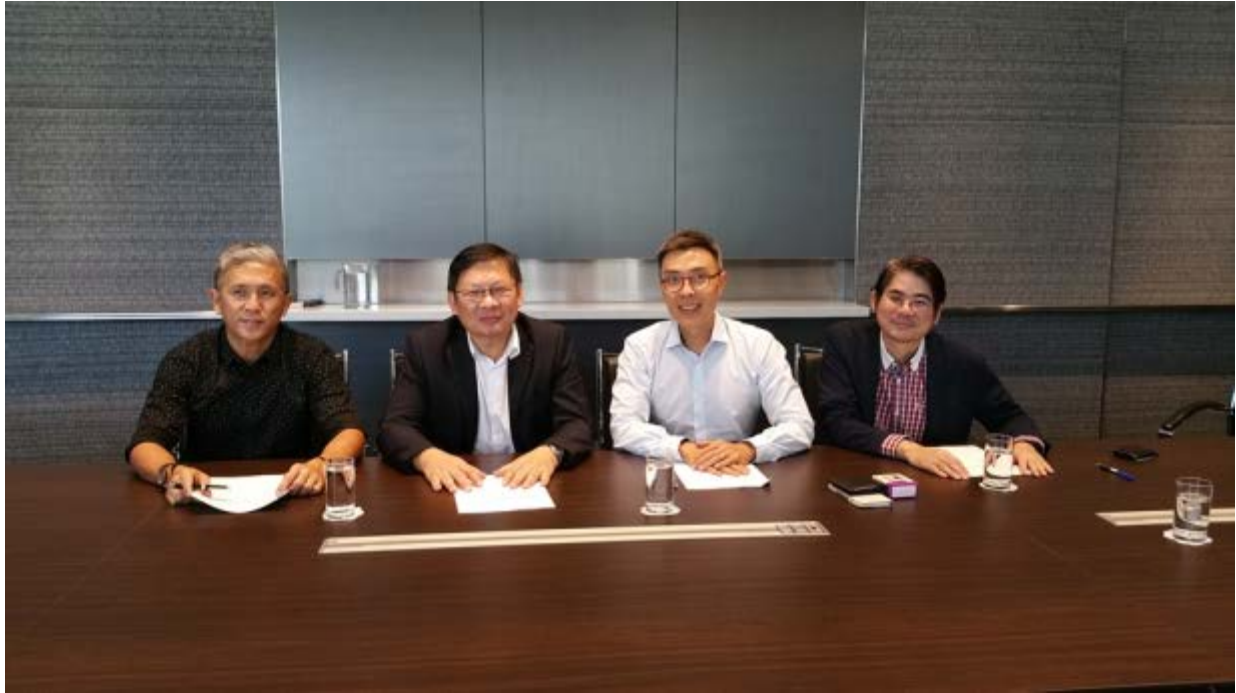
## Singapore Consortium Makes Maiden Foray into Sarawak's Eco-tourism Sector with Regal International Group

RIG will be providing overall lead in the project study.
